School Rules and Regulations 2025

1. School hours:
 - Nursery section 8:00am – 3:30pm
 - Day care section: 8:30am – 3:30pm
 - Primary section:
 - Primary one to primary four: 7:30am -- 4:00pm
 - Primary five to primary seven: 7:30am -- 5:00pm
2. All Pupils shall report to school punctually between 7:30am and 8:00am from Monday to Fridays.
3. All Pupils shall attend school regularly throughout the school term and year. Parents shall call the class teacher to inform them if their child is going to miss school on any given day for any reason.
4. All parents shall pick their children from school very promptly between 4:00pm and 5:00pm. If a parent is unable to pick their child, they will call to inform the Class Teacher or School Administration, who they have delegated to do so. Persons other than parents who will be picking up the child must bring with them the **Child Pick-up Identity Card**.
5. Parents that come to pick their children after 6:00pm will be required to pay a fine of Uganda Shillings Five Thousand per child picked late per day.
6. All Pupils shall report to school in clean, well-ironed school uniform and clean, polished shoes and clean fresh socks.

Monday, Wednesday and Friday

- (a) Girls Checked light green dresses, cream shirt, dark green sweaters, green socks and black Shoes and 3 white handkerchiefs.
- (b) Boys Light green shorts, cream shirt, and dark green pull-over, green socks and black shoes, and 3 white handkerchiefs.

Tuesday and Thursday

- (a) Girls White T-Shirt, dark blue shorts, green socks and white canvas shoes.
- (b) Boys White T-Shirt and dark blue shorts and green socks and white canvas shoes.

7. Parents shall not provide children with money or food to bring to school since break tea and lunch will be provided for all students in the school.
8. All parents shall be involved in the education of their child, helping them to do their homework and signing off homework completed by their child every single day.
9. Parents will endeavor to meet with their child's Class Teacher at least once a month to review their child's performance.
10. All parents shall attend the School Open Days, Parents Days, and Child Progress Review days as will be scheduled by the school administration.
11. The payment of school fees must be completed before the end of the term, short of which the Pupil cannot be admitted for the next term unless previous arrears have been completed.
12. Parents shall notify the school at the time of registration and in the course of the term if the child has developed any health complications. They shall also disclose the nature of the complication and how to handle this when a health incident occurs.
13. Parents will keep sick children at home until they recover and are ready to resume learning. The school administration shall be kept informed of incidences of sickness of the child.
14. Parents shall notify the school in the case of change of phone numbers, physical residential addresses and emergency contacts.
15. All Pupils shall participate in the school's Christian spiritual development activities such as prayers, praise, Bible study etc. as may be scheduled by the school administration. This is compulsory for all Pupils.
16. All Pupils shall be courteous and respectful towards each other and school staff.
17. All Pupils shall be truthful to their communication with fellow pupils, parents and staff.
18. No Pupil shall use abusive language or fight with other Pupils, teachers or any other person for any reason. Pupils may be expelled for such behavior if they do not reform.
19. No Pupil shall be engaged in stealing property of the school, pupil, teacher or any other person for that matter. Any Pupil engaged in theft will be expelled from the school if they do not reform.
20. In the event that Pupils destroy or lose school property, they will be required to repay the school for the value of property destroyed.
21. No Pupil shall be allowed into the school with inappropriate items such as cigarette, drugs, alcohol and pornographic materials, make-up, indecent clothing etc.
22. Pupils shall report to school very clean and smartly dressed and keep their hair well groomed.
 - a. Boy children will have their hair kept short.

- b. Girl children may grow long hair for it is their glory. They shall however keep their hair well-combed or very neatly plaited. No child will be allowed in school with chemically treated or permed hair as such is unhealthy for the children.
 - c. The children will not be allowed to wear make-up of any kind to school as this is not appropriate for children of this age.
- 23. No Pupil shall leave the school gate without the permission of the headteacher/class teacher/teacher on duty.
- 24. It is the responsibility of parents to teach their children good manners and ensure they are disciplined.
- 25. There shall be **no corporal punishment of children** in this school. Teachers will use alternative means to discipline the children. However, parents of children with behavioral problems will be called to meet with school administration. In event parents do not come, the child will be sent home until they can report to school with their parents to discuss the challenges.
- 26. Parents/Guardians are strongly advised not to use corporal punishment for children at home because this will undermine school efforts to discipline children without beating them. Children who are used to corporal punishment may not listen to teachers who do not beat them.
- 27. All school birthdays will be celebrated on the last school day of the month. Parents are encouraged to give their children a token gift to present to the birthday-babies of the month. This will promote thoughtfulness, love and sharing among the children.
